Mr. Mohamed Lemine OULD DHEHBY

Director-General of the Treasury and of Public Accounting – Mauritania



Mr. Mohamed Lemine OULD DHEHBY is the current Director-General of the Treasury and of Public Accounting at the Delegated Ministry attached to the Ministry of the Economy and of Finance in charge of the Budget

He has a PhD from the University of Nice in economic sciences and a diploma in english language and literature

He has held a variety of positions in his fields of expertise (Public Finances, Macroeconomy, Economic situations and forecasts): Director in charge of land registering and the State’s properties; Director in charge of Economic Cooperation; Director of the Treasury; Director of Economic forecasts and analyses; Macroeconomic consultant at the Mauritanian centre for political analyses; and for a couple of years Department Head of studies at the Budget’s Directorate

He is a member of Mauritania’s Central Bank General Council and chaired several administrative committees: the National committee for public debt, the Coordination committee of monetary and budgetary policies, the National follow-up committee for oil revenues and the Follow-up committee for mining revenues.

Mr. Ollivier GLOUX

General Administrator of Public Finances - FRANCE



Mr. Ollivier GLOUX is a graduate of the Institut d'Etudes Politiques of Paris (1975) and the National School of Administration (1989).

From 1989 to 2006, he held several positions within the General Directorate of Public Accounting (DGCP), including that of Deputy Director in charge of Local Government. He was technical adviser of the Minister of the Budget (1997-2000), in charge in particular of the relations between State and Local authorities.

He worked then in the deconcentrated network of the DGCP as Treasurer-Payer General - Department of Eure (2006 to 2014), and most recently as Departmental Director of Public Finance of Seine-Saint-Denis (2014 to 2017).

He has been retired since November 2017 and is now engaged in international cooperation missions on local finance issues.

From 1993 to 1995 he worked for the Ministry of Cooperation as Head of the Financial Studies Department.

Ms. Van Nguyet Vu

Official – Vietnam State Treasury



Ms. Van Nguyet Vu has been working for Vietnam State Treasury since 2013. After graduating as a bachelor of economics from Foreign Trade University (Vietnam) and working for Vietnam State Treasury, Ms. Van Nguyet Vu studied public finance management and cash management in China and New Zealand.

Her main duties include reviewing, proposing and drafting policies and regulations related to Vietnam State Treasuries' functions such as cash management, dematerialisation, non-cash payment and state budget fund management; giving guidelines to provincial and district treasuries for the implementation of new regulations and policies; reviewing and proposing business procedure innovations. Starting from 2018, Ms. Van Nguyet Vu has been entrusted to review the results of Vietnam State Treasury Development Strategy to 2020 and propose a new development strategy for 2021 – 2030 along with other colleagues.

Mr. Cheikh NDIAYE

Director of the Local Public Sector - SENEGAL



Mr. Cheikh NDIAYE is Senior Inspector of the Treasury specialised in Decentralisation, Finance and local taxation matters. He is the current Director of the local public sector.

Holder of a Master's degree in Private Law (Business Law option), of a Diploma of Advanced Studies in General Private Law and Public Law (Option Decentralization and Local Government Management) and of a Diploma of Specialised Graduate Studies in International Relations (Option Action and international policies of local authorities), Mr. NDIAYE graduated from the National School of Administration (ENA) of Senegal in 2002.

After a first assignment within the Regional Treasury of Ziguinchor (South Zone of Senegal) where he served as Director of the postmaster, Mr. NDIAYE joined in 2004 the central administration. He was in charge of the Regulation and Monitoring of projects and programs supporting Decentralisation and Local Development within the Office of the Communities at the Directorate General of Public Accounting and Treasury. He was then appointed public accountant between 2006 and 2015 first as a tax collector of the Matam region (North East) 2006-2009, then as a Regional Paymaster Treasurer of Fatick (Central Zone) 2009-2012, and finally as a Regional Paymaster Treasurer of Saint Louis (North Zone) 2012-2015.

He has been appointed Director of the Local Public Sector since 2015.

Mr. Ndiaye is also a lecturer at the National School of Administration (ENA) of Senegal and Gaston Berger University of Saint Louis.

Mr. Anicet BANDENGA

Central accounting officer - GABON



Holder of a master's degree in management sciences and a diploma from the National School of the Treasury of Noisel (1994) Mr. Anicet BANDENGA held several positions within the General Directorate of Public Accounting (DGCP). He was successively Chief of Service of the windows within the General Treasury (1996), Provincial Treasurer of Ogooué-Ivindo (1997-1999), and finally Director of Heritage and Means (1999-2000).

He was then Payor of Gabon in different countries (from 2001 to 2006). Returning to the DGCP, he successively served as Accountant from 2006 to 2010, and then as Inspector of Services from 2010 to 2017.

Mr. Anicet BANDENGA has been Central Treasury Accountant since October 2017.

Mr. Lionel YONDO BLACK

Director of the French Development Agency (AFD) - MAURITANIA



Mr. Lionel Yondo is the current Director of AFD in Mauritania. He held several positions within AFD: Country Manager in the Africa Department in charge of Ethiopia, Djibouti and Sudan. He participated with AFD's local agencies and in collaboration with other technical and financial partners (World Bank, European Union, ADB ...) in setting up and monitoring funding in several sectors. He also facilitated the themes of public-private partnership (PPP) and the private sector in Africa. He was previously Senior Legal Adviser in the AFD Operations Department.

Mr. Yondo spent five years within the World Bank's Trade & Competiveness Department as a Senior Operations Officer to assist in reform and support programs to support private sector development.

Former lawyer at the Paris Bar, he had the opportunity to work in several international law firms on projects in fields as diverse as infrastructure, financial services, agribusiness, education training and health. He also participated in the negotiation of numerous contracts and institutional reforms involving states, financial institutions, public or commercial companies.

Holder of a Master's degree in Banking and Finance Law and of a Master's degree in African Studies from the University of Paris I Pantheon-Sorbonne, he also holds the CAPA obtained at the Training School of the Paris Bar. Mr. Yondo is also a graduate of ENA and University Paris-Dauphine where he obtained a Master of Public Management (MPA).

Mr. Bachirou MOHAMADOU

Head of the International Financial Relations Unit - Cameroon



Mr. MOHAMADOU is Senior Inspector of the Treasury. Appointed on September 18, 2018, Head of the International Financial Relations Unit within the Financial and Monetary Cooperation Department of Cameroon, Mr. BACHIROU graduated from the National School of Administration and Judiciary (ENAM) of Yaounde (2005) and the National School of Public Treasury of Noisiel (2006). He worked as a Research Officer in the Office of the Director General of Treasury, Financial and Monetary Cooperation of Cameroon between 2006 and 2011.

He worked as Deputy Director of the Regulations of the State Budget and Accounts from January 11, 2011 to September 18, 2018, within the Directorate general of public Accounting. He teaches Public Accounting at ENAM and participates in several conferences and seminars organised by AIST since 2007.

Mr. Lofti MISSOUM

Director of Public Finances - Morocco



Mr. Lofti MISSOUM is Director of Public Finance since April 2016. He worked within the General Treasury of the Kingdom, as Director of Control, Audit and Inspection and Acting Director of Public Finance from December 30, 2014 to April 2016, Director of Control, Audit and Inspection from December 30, 2013 to December 30, 2014, Head of the Inspection Department (2008-2013), Head of the Audit and Inspection Department (2007-2008), Head of the Public Debt and Portfolio Department (2001-2002), Head of the Development of Banking Network Department (1999-2001) and Head of the Public Expenditure Visa Department (1994-1998).

Holder of a Master's degree with honors in Industrial Economics from the University of Paris XIII, of an extensive degree and of a Doctorate in Economics from the University of Paris X-Nanterre and student of the National School of Treasury Services, he has published in national dailies and weeklies (Economic Life, The Economist and Opinion), in the magazine Al Khazina (General Treasury of the Kingdom of Morocco) and international newspapers (French review of Public Finances).

Mr. Lassina FOFANA

Deputy Director-General of Treasury and Public Accounting - Ivory Coast



Senior Administrator of the Financial services, Mr. FOFANA is Deputy Director-General of Treasury and Public Accounting since the 8 June 2011

Mr. FOFANA graduated from the National School of Administration (ENA) in 1986 with an upper Cycle Diploma, Treasury option. From 1982 to 1984, he obtained a Degree and a Master in Sociology and a DEA in the Sociology in the Economy of Development, option Third World, in the University of Sciences and Technologies of Lille, France

He joined the Treasury in 1986 and was appointed proxy holder of the Departmental Treasury of Gagnoa from 1987 to 1988. From 1988 to 1991, Mr. FOFANA served as Tax collector of San Pedro and then as Departmental Paymaster of San Pedro from 1991 to 1994

From 1994 to 1997, he was Departmental Paymaster of Divo. From 1997 to 2000, he was Senior Controller Inspector in the Treasury General Inspection. During this period, it also served as part-time teacher, charged to teach the Financial and Accounting management of local authorities in the upper and middle cycle of the National School of Administration

From August 2000 to 2005, he was appointed Accounting officer of Public Debt, in charge of the financial and accounting management of the Public Debt and co-financed projects. From 2005 to 2010, he served as technical adviser of the Treasury General Directorate, in charge of the quality approach issues. In February 2010, he became Director of the quality and standardisation of Public Treasury until it's nomination as Deputy General-Director in 2011.
